SGM MINUTES

1. Meeting Opening

- 1.1 GG opened the Thebemed Medical Aid Scheme (Scheme) Special General Meeting (SGM) at 11h15. He explained that the purpose of the SGM was to elect four member-elected trustees as per the amended Scheme rules.
- 1.2 GG explained that the SGM was held physically at Birchwood Hotel & OR Tambo Conference Centre in Boksburg, and there were members who joined the meeting virtually on various voting stations.

2. Welcome, and introduction of the attendees.

- 2.1 GG welcomed all the members of the scheme that were present.
- 2.2 GG also welcomed and introduced the Council for Medical Scheme's representative Mr. Sibongubuhle Situnda who was there to oversee the proceedings.
- 2.3 GG further welcomed and introduced external auditors Elsa Lehmann and Karli Prinsloo from Strachan and Crouse who were to verify the election results.
- 2.4 GG acknowledged the presence of BM and her team from the EleXions Agency.
- 2.5 The presence of Board members and the Principal Officer of the Scheme was also acknowledged by GG, including the presence of WM who joined the meeting virtually from the Rustenburg voting station.

3. Announcement of the venue safety procedures and meeting schedule

3.1 GG urged each venue to observe its own safety procedures.

4. Quorum confirmation

- 4.1 The PO announced that the SGM was convened in terms of rule 26 of the Scheme rules, which stipulated that 50 members were required to reach a quorum.
- 4.2 The PO allowed representatives at various voting stations to confirm the number of members who were physically present at each voting station as follows:

- 4.2.3 Petra Diamonds VT confirmed that 50 members were present.
- 4.2.4 Seriti New Denmark TN confirmed that there were no members present.
- 4.2.5 Seriti New Vaal NM confirmed that there were no members present.
- 4.2.6 First National Battery ST confirmed that there were no members present.
- 4.2.7 First National Battery WN confirmed that 1 member was present.
- 4.2.8 Birchwood Hotel PO confirmed that 1 member was present.
- 4.3 The PO confirmed that a quorum was met with 73 members in attendance both physically and virtually at various voting stations.
- 4.4 GG referred members to the SGM agenda (the agenda). The agenda was confirmed with no additional items.
- 4.5 GG adjourned the meeting at 11h30 for voting purposes.
- 4.6 The meeting reconvened at 14h00 and GG gave direction that any member who was still in the queue at various voting stations would be allowed to vote.
- 4.7 GG adjourned the meeting at 14h00 for counting of the votes.
- 4.8 The meeting was reconvened at 15h10. GG expressed gratitude to the attendees and the members of the Scheme for their patience during the delay in announcing the voting results.
- 4.9 GG informed the attendees that the EleXions Agency representatives had not yet concluded counting and auditing of the votes. GG apologized for the delay and advised that as soon as the feedback was available, the members would be duly informed.

5. Announcement of the election results

- 5.1 The meeting was reconvened at 15h55. GG welcomed everyone back to the meeting and handed it over to BM from the EleXions Agency who was there to announce the election results.
- 5.2 BM explained that the Elexions Agency was involved in the elections process from the nomination process, during the Annual General Meeting that was held in June

5.3 BM explained that there were 12 806 active principal members of the Scheme and that 334 members cast their votes on that day. The distribution of votes per voting station was as follows.
